In continuation to this office advertisement of even No. Dated 22nd Aug'2012, Applications are invited from Citizen of India for recruitment of the following posts of Upper Division Clerk and Lower Division Clerk against Civil Police/IRBN under Arunachal Pradesh Police. The details are given herein after.

2. ESSENTIAL QUALIFICATION.

a) For the post of UDC

- i) Graduation from a recognized University
- ii) Basic knowledge in Computer Application (to be supported with certificate course of minimum 6 months issued from recognized institute.

b) For the post of LDC

- i) Matriculation or equivalent educational qualification from a recognized Board.
- ii) Typing speed of 30 words per minute.
- iii) Basic knowledge in Computer Application (to be supported with certificate course of minimum 6 months issued from recognized institute.

3. AGE ELIGIBILITY:- The age of candidate should be between **18 to 28** years as on 01-01-2015. Relaxation of upper age limit for APST candidates is given up to maximum of 5 (five) years.

4. APPLICATIONS FORM: - The specimen of application form can be downloaded from the website of Arunachal Pradesh Police at www.arunpol.nic.in.

5. DATE OF RECRUITMENT:-

i) Receipt of applications: The application forms accompanied by duly attested copies of certificates of educational qualification, proof of age as per school certificate/Admit card/Birth registration certificate, Caste/Tribe certificate, employment exchange registration certificate of A.P., self addressed envelope with postal stamp worth Rs.5/- and three recent passport size photographs with self signature on back will be received w.e.f **19-01-2015** at PHQ on all working days. A *Treasury Challan of Rs.10/- for APST candidates and Rs.40 for general candidates in favour of Assistant Inspector General of Police (E), P.H.Q. Itanagar under Head of Accounts '0055' Police, should be also enclosed.*

The application forms can either be sent by ordinary post or directly submitted by hand at PHQ Itanagar.

ii) Last date of receipt of applications: 10-02-2015. No application shall be accepted after expiry of last date of submission i.e., **10-02-2015 up to 1600 hrs.**

NB: The candidates will be required to bring along with the original documents / testimonials submitted along with application form at the time of interview for verification & authentication. The candidature shall be summarily rejected on non-production of original documents during scrutiny

6. a) WRITTEN EXAMINATION. The eligible candidates will be put through written test in the following subjects.

b) Typing speed (for the post of LDC): 30 words per minute

c) Basic knowledge in Computer Application: 50 marks

Dates will be intimated in admit card / call letter.

NB: -

i) The written examination will be of Multiple Choice on OMR answer scripts.

ii) The minimum pass marks in written examination will be 33% in each subject and 45% in aggregate.

iii) *There will be no negative marking.*

iv) *The typing speed test will be qualifying in nature and no marks will be given. However, candidates failing in typing speed test will be summarily rejected.*

5) **INTERVIEW:** - The candidates scoring higher marks in written test / computer test in order of merit will be called for interview/viva voce at the ratio of 1:3 with respect to the vacancies. The date, time and place will be announced separately by the police department.

Total marks for the interview will be 40.

i) The final merit list of the selected candidates will be made on the basis of overall marks secured in the written test/computer test and interview put together.

ii) **MEDICAL EXAMINATION / CHARACTER & ANTECEDENT VERIFICATION:-** Appointment of provisionally selected candidates shall be subject to production of medical fitness certificate from Medical Officer of Govt. Hospital and satisfactory verification of character and antecedent.

No TA/DA will be admissible to the candidates for attending in the recruitment process. The candidates shall have to bear their own expenses and arrange for their boarding/lodging on their own.


