A copy of Government of India, Ministry of Defence letter No.1(13)/2012/D(Pen/Policy)dated 17.01.2013 on the above subject is forwarded herewith for information and necessary action which is self explanatory.

2. The above Government letter provides improvement in pension to bridge the gap in pension of Pre- 1.1.2006 and Post 1.1.2006 discharged JCOs/ORs of the Armed Forces.

3. The improvement in pension as per the above Government of India, Ministry of Defence letter will be effective from **24.09.2012.**

4.1 **Applicability-**

These orders are applicable to the JCOs/ORs and Hony Commissioned officer pensioners of regular Armed Forces (including Defence Security Corps and TA personnel) who were/are in receipt of the following types of pension as on **24.09.2012** but were discharged/ retired prior to 1.1.2006.

- (a) Service Pension
- (b) Special Pension
- (c) Ordinary Pension/Mustering out Pension to Pre 01.06.1953 retirees.
- (d) Invalid Pension
- (e) Service Element of Disability Pension
- (f) Service Element of War Injury Pension / Liberalised disability pension

These orders are also applicable to Non-Combatants (Enrolled) (NCs(E)) of regular Army and Air Force and Ex-State Forces pensioners drawing pension as on **24.09.2012**.

4.2 Non-Applicability-

The provisions of the letter, however, do not apply to all the family pensioner of JCOs/ ORs and the Commissioned officers and their families. These orders also do not apply to UK/HKSRA/KCIOs pensioners, Pakistan and Burma Army pensioners. These orders do not apply to Reservist Pensioners, pensioners in receipt of disability element only and pensioners in receipt of Ex-gratia payments.

4.3 The following elements will continue to be paid as separate elements in addition to the pension revised under these orders –

- (a) Monetary allowance attached to Gallantry Awards such as Param Vir Chakra, Ashok Chakra etc.
- (b) Constant Attendance Allowance (CAA) where admissible to disability pensioners.
- (c) Disability Element / war injury element if any.

5. Revision of Pension with reference to Pension Tables by Pension Disbursing Agencies

5.1 Where pensioner has rendered qualifying service of 15 years and above and is

in receipt of Service Pension, Special Pension, Invalid Pension, Service Element of Disability Pension, PDAs are required to revise the pension on their own as per Tables appended to Min of Defence letter enclosed after ascertaining the actual qualifying service (shown in "Q.S." column) subject to maximum term of engagement for each rank as applicable from time to time, rank and group for which pensioned from the initial grant PPO matching existing Pension as on 1.7.2009 as shown in relevant column of the Tables <u>without calling or waiting for any applications</u> from the affected pensioners.

5.2 Where PDAs have not revised pension w.e.f 01.07.2009, or otherwise corrected as per MOD letter No. PC 10(1)/2009 –D (Pen/Pol) dated 08.03.2010 as amended by MOD letter of even No. dated 15.04.11 and dated. 27.03.2012 (This office circular No. 430 dated 10.03.2010 as amended by Circular No. 461 dated 11.05.2011 and Circular No. 482 dated 19.04.2012) pension payable from 01.07.2009 may be paid correctly first as per instructions contained in circular No. 430 dated 10.03.2010 and thereafter in terms of the Government letter enclosed.

5.3 In some cases where the PSAs had already issued Corr PPOs in respect of pre-2006 retirees showing rates of pension as on 01.01.2006 and 01.07.2009, PDAs are to revise the pension as per these orders with effect from **24.09.2012** with reference to the particulars as mentioned in the Corr Pension Payment Orders.

5.4 A comprehensive list of maximum terms of engagement for JCOs/ORs of Armed Forces applicable from time to time including emergency period is enclosed as **Appendix-X** to enable all PDAs to revise the pension correctly for the length of qualifying service for which the pensioner has been pensioned initially.

5.5 A table indicating equivalent rank of JCOs/ORs in Army, Navy and Air Force is also given in **Appendix Y** to this circular for guidance of Pension Disbursing Authority for determining pension admissible as per this GOI, MOD letter enclosed.

6. Cases to be referred to PSA –

6.1 The initial Pension Payment Order (PPO) or its Corrigendum PPO (Corr PPO) indicates rank, group and qualifying service for which the individual has been pensioned. In case, however, any information regarding qualifying service, rank, group etc., is not available with Pension Disbursing Agencies, such cases may be referred to **Pension Sanctioning Authority** concerned on the proforma <u>enclosed as Annexure-A</u>. The Pension Sanctioning Authorities concerned will provide the requisite information from the available records within 30 days of the receipt of request from the Pension Disbursing Agencies.

6.2. Special pension/Invalid pension/ Service element of disability pension in respect of PBOR discharged with less than 15 years qualifying service and service Pension to TA personnel irrespective of their qualifying service would also need to be revised in terms of these orders by Pension Sanctioning Authorities. Specific Table indicating revised rate of pension for the purpose have not been prepared. PDAs will refer such cases to PSAs concerned <u>as per specimen given in Annexure- B to Ministry of Defence letter enclosed.</u>

6.3. Pensioners in receipt of two pensions- In case of pensioners who are in receipt of more than one pension i.e. one for Armed Forces service and other from any other Deptt/Ministry etc, pension for Armed Forces service should <u>only</u> be revised as per the relevant Table.

The DSC personnel who are receiving two pensions, one for regular Army Service another for DSC Service, their pension for DSC Service will <u>not</u> be revised by the Tables No. 7 to 11. The pension for regular Army service will be revised under these orders by the PDAs. A reference for revision of pension for DSC service, will be sent to PCDA (P) on **Annexure A** to the Ministry of Defence letter enclosed. However, DSC pensioners receiving only one pension for DSC service their pension will be revised under these orders from Tables No 7 to 11

6.4. Similarly revision of Service element of war injury pension and Service element of liberalised disability pension cases will also be required to be done by the PSAs concerned. Such cases will also be forwarded by the PDAs to the PSAs concerned through respective Record office in the enclosed **Annexure- C** to Min of Defence letter. The addresses of Record offices are given in **Appendix- Z** to this circular.

7. Miscellaneous and Reports

7.1 The Govt. has also desired that all the Public sector Banks including IDBI Bank, ICICI Bank Ltd, HDFC Bank Ltd, AXIS Bank, disbursing pension would *render a monthly progress report as per the proforma_*(Annexure- D) prescribed under Ministry's above quoted letter dated **17.01.2013** to the office of the PCDA (Pensions) Allahabad. All PDAs are therefore, enjoined upon to ensure rendition of the said report. It is also enjoined upon them that all the columns in proforma prescribed by Ministry of Defence must be filled in complete and correct manner before its rendition **to the Group Officer of Audit Section of the office of the PCDA (P) Allahabad).** It is also requested that a **Soft copy** and one more copy of the requisite proforma, be invariably sent separately along with the pension payment scrolls regarding payment of improved pension.

7.2 The DPDOs will render the monthly progress report as per <u>Annexure D</u> to the office of the PCDA (P) Allahabad with copy to their respective CsDA i.e. CDA (PD)/CDA (WC) and CDA Chennai as the case may be.

8. Miscellaneous instructions-

8.1. No arrears on account of revision of pension will be admissible for the period prior to **24.09.2012.**

8.2 Additional Pension to the pensioners 80 years of age and above- The improved pension will be basic pension from **24.09.2012** and therefore additional pension available to old age pensioners/ family pensioners on attaining the relevant age (80 years and above) shall also be revised by PDA.

8.3. **Dearness Relief** - The pension Disbursing Agencies will pay dearness relief as authorized by Deptt of P& PW, Ministry of Personnel, PG & Pensioners from time to time on improved pension and additional pension payable to old age pensioners treating it as basic pension.

8.4 **Any overpayment** of pension coming to the notice or under process of recovery shall be adjusted in full by the Pension Disbursing Authorities against arrears becoming due on revision of pension on the basis of MOD letter enclosed.

8.5 A suitable entry regarding revised pension should be made by the PDAs in Check Register/Payment Register/Pension Payment Scroll Register/ Pension Book/ Certificate.

9. Points of doubt, if any, relating to revision of pension under the subject Government order may be immediately referred to the concerned PSAs by name as given below. However, any clarification regarding the rule position in the Government letter dated 17.01.2013 and this office Circular No.

500 dated 17.01.2013 of this office may be referred to the office of the PCDA(P),Draupadi Ghat, Allahabad 211014.

Subject: - Implementation of Government decision on the recommendations of the Committee of Secretaries 2012 on the issues related to Defence Service Personnel and Ex-Servicemen- Improvement in pension of JCO/OR retired/discharged/invalided out of service prior to 1.1.2006.

Sir,

The undersigned is directed to refer to this Ministry's letter No. PC 10(1)/2009-D (Pen/Policy) dated 8.3.2010 according to which with effect from 1st July 2009, pension of all ranks of pre-1.1.2006 JCO/OR retiree in Army, Navy and Air Force (including DSC and TA) has been reckoned at 50% of notional pay in the post-1.1.2006 revised pay structure corresponding to the maximum of the pay scales applicable from 10.10.1997 of the rank and group continuously held for last 10 months preceding retirement/discharge/invalidment. The amount of pension so determined has to be reduced pro-rata if the reckonable qualifying service including rank weightage (except TA personnel) is less than service required to earn full pension.

2. A Committee of Secretaries headed by Cabinet Secretary was constituted by the Government to consider various issues on pension of Armed Forces personnel and Ex-Servicemen, who have recommended the following to bridge the gap in pension between pre and post-1.1.2006 JCO/OR pensioners-

2.1 The pension of pre-1.1.2006 JCO/OR pensioners may be determined on the basis of notional maximum for the ranks and group across the three Services; and

2.2 Current weightage in qualifying service of Sepoy, Naik and Havildar may be increased by two years.

3. The above recommendations of the Committee has been accepted by the Government and the President is pleased to decide that with effect from 24th September 2012, the service pension, invalid pension, special pension, service element of disability pension and service element of war injury/liberalized disability pension (in release cases only) of all pre-1.1.2006 JCO/OR pensioners of Army, Navy and Air Force (including DSC & TA) shall be recomputed in terms of Para 2 of this Ministry's above said letter dated 8.3.2010 after determining the highest of notional pay in the revised pay structure corresponding to maximum of pay scales of Fifth CPC across the three Services equivalent to the rank and group in which pensioned. Before determining highest of notional pay of equivalent ranks across three Services, 50% of highest classification allowance (rates effective from 1.9.2008) shall also be added in the notional pay of the ranks in Army, wherever applicable.



3.1 The President is also pleased to decide that for computation of pension in terms of this order, the rank weightage in qualifying service for the rank of Sepoy, Naik and Havildar (except for TA personnel) shall be taken as 12, 10 and 8 years subject to a maximum qualifying service of 32 years. However, in case an individual's qualifying service works out to be more than 32 years with existing weightage, he would continue to get the benefit of that and there will be no enhancement of weightage in such cases.

3.2 The notional pay in the revised pay structure for pre-1.1.2006 JCO/OR granted Honorary Commission as Lieutenant and Captain shall also be worked out by adding pay in the revised pay band corresponding to the fixed pay of Fifth CPC (in terms of Para 9(a)(i) of SAI 1/S/2008 as amended and equivalent instructions for Navy & Air Force) plus the Grade pay and Military Service Pay introduced under Sixth CPC revised pay structure.

3.3 All other provisions contained in Para 2 and Para 3 to 3.4 of this Ministry above mentioned letter dated 8.3.2010 which remain unchanged, shall continue to be followed.

4. The President is also pleased to decide that service element of war injury pension/liberalized disability pension in respect of JCO/OR invalided out of service prior to 1.1.2006 shall be reckoned as under-

4.1 For determining the notional pay last drawn in respect of JCO/OR invalided out of service prior to 10.10.1997, the provisions laid down in Para 4.1 of this Ministry above quoted letter dated 8.3.2010 shall be followed.

4.2. The notional Pay in the pay band of post-1.1.2006 revised pay structure corresponding to the notional pay determined in case of JCO/OR invalided out of service prior to 10.10.1997 vide Para 4.1 above and corresponding to last pay drawn in case of JCO/OR invalided out of service on or after 10.10.1997 but before 31.12.2005, shall be determined at the same number of stage in the fitment table attached to SAI 1/S/2008 or equivalent instructions for Navy & Air Force. For this purpose, the fitment table considered as having highest maximum of pay scales across the three Services for equivalent rank and group in which pensioned, as determined vide para 3 above, shall be taken into account.

4.3 The notional emoluments last drawn for rank and group shall consist notional pay in the pay band as determined vide Para 4.2 above plus Grade pay, Military Service pay and 'X' Group pay, where applicable of the rank and group held at the time of invalidment.

4.4. The service element of war injury pension/liberalized disability pension in respect of all PBOR invalided out of service prior to 1.1.2006 shall be notionally recomputed with effect from 24th September 2012 at 50% of the notional emoluments last drawn (determined as per 4.3 above) in the Post-1.1.2006 revised pay structure with reference to the qualifying service already admitted. The amount of service element so determined shall be the pension for 33 years of reckonable qualifying service including rank weightage (except for TA personnel). The provisions at Para 3 to 3.3 above, shall equally apply for determining the amount of service element of war injury pension.

NON- APPLICABILITY

5. The provision of these orders do not apply to the family pensioners of PBOR and Commissioned Officers and their family. These orders also do not apply to UK/HKSRA/KCIOs pensioners and Pakistan/Burma pensioners. The following elements shall continue to be paid as separate elements in addition to the pension revised under these orders-

5.1 Monetary allowance attached to gallantry awards viz. Param Vir Chakra etc.



5.2 Constant Attendance Allowance, where admissible.

6. The provisions of this order shall be effective from 24th September 2012. No arrears on account of revision of pension based on notional fixation of pay shall be admissible for the past period. However, If a pensioner to whom the benefits under these orders accrues has died / dies before receiving the payment on account of arrears, the life time arrears (LTA) will be disposed off as per the extant orders contained in Para 12 of this Ministry above said letter dated 8.3.2010

METHODOLOGY FOR IMPLEMENTATION

7. All Pension Disbursing Agencies handling disbursement of pension to Defence pensioners are hereby authorized to carry out revision of service pension/special pension/ invalid pension/service element of disability pension with effect from 24th September 2012 to the affected pensioners drawing pension with 15 years or more qualifying service in terms of these orders without calling for any applications from the pensioners and without any further authorization from the concerned Pension Sanctioning Authorities and pay the arrears on account of such revision.

8. In order to quicken the processes of revision of service pension, special pension, invalid pension, service element of disability pension with 15 years or more qualifying service, total 25 tables indicating revised pension payable with effect from 24th September 2012, have been prepared for PBOR of Regular Army, Navy, Air Force and DSC who retired/discharged/invalided out from service prior to 1.1.2006 and drawing pension as on 24th September 2012, and are enclosed as <u>Appendix</u> to this letter. The appended tables indicate the existing pension as on 1.7.2009 and revised pension payable with effect from 24th September 2012. Pension Disbursing Agencies shall revise the pension with reference to applicable Table for the rank and group in which the JCO/OR was pensioned. The revised rate of pension indicated against each qualifying service in the pension tables appended to this letter is inclusive of rank weightage applicable for various ranks, Pension Disbursing Authority shall refer the actual qualifying service as shown in Column-1 for carrying out revision subject to maximum term of engagement for each rank as applicable from time to time. In addition, dearness relief sanctioned by the Government from time to time and applicable quantum of additional pension for pensioners of 80 years of age and above, is also payable.

9. The initial Pension Payment Order (PPO) or its Corrigendum PPO (Corr PPO) indicates rank, group and qualifying service for which the individual has been pensioned. This information is available with Pension Disbursing Agencies as they have revised pension of all such pensioners in the recent past in terms of various Government orders. In case, however, any information regarding qualifying service, rank, group etc., is not available with Pension Disbursing Agencies, such cases may be referred to Pension Sanctioning Authority concerned on the proforma enclosed as <u>Annexure-A</u>. The Pension Sanctioning Authorities concerned will provide the requisite information from the available records within 30 days of the receipt of request from the Pension Disbursing Agencies.

CASES REQUIRING REVISION FROM PSAs

10. Pension of PBOR pensioners who are in receipt of Special Pension, Invalid Pension and service element of Disability Pension for less than 15 years of qualifying service would also need to be revised in terms of these orders. Specific Tables for the purpose have not been prepared for the reason that each of such cases will be unique one as rank, group and qualifying service will differ from case to case and hence standard Tables cannot be prepared. Pension Disbursing Agencies shall refer such cases directly to the Pension Sanctioning Authorities concerned in the format enclosed as <u>Annexure-B</u> to this letter.

11. Specific tables for revision of pension in respect of pre-1.1.2006 Territorial Army pensioners have also not been prepared as Pension Disbursing Agencies could not revise such cases due to non-applicability of weightage in qualifying service and provision for reduction in



pension in respect of TA pensioners who have completed 15 years or more but less than 20 years of aggregate embodied service. Such cases may also be referred by Pension Disbursing Agencies directly to the Pension Sanctioning Authorities concerned in the format enclosed as <u>Annexure-B</u> to this letter.

12. Similarly, revision of service element of war injury pension/liberalized disability pension in all cases of PBOR irrespective of the qualifying service shall also required to be done by the Pension Sanctioning Authorities concerned for the reason that the crucial information relating to last pay drawn and the maximum terms of engagement to the specific rank for which pension would need to be verified with reference to the original records are held by the Pension Sanctioning Authorities. Such cases shall also be forwarded by the Pension Disbursing Agencies to the Pension Sanctioning Authorities concerned through respective Record Office in the prescribed proforma enclosed as **Annexure-C** to this letter.

METHODOLOGY FOR REPORTING

13. An intimation regarding disbursement of revised pension shall be sent by the Pension Disbursing Agencies to the Office of the PCDA(P) Allahabad on monthly basis in the format prescribed as <u>Annexure-D</u> to these orders a copy of which shall also be provided by the Pension Disbursing Agencies to the pensioners concerned for their information. Those Public Sector Banks who are disbursing Defence pension through Central Pension Processing Centers (CPPC), the monthly progress report may be furnished by the CPPC of the bank directly to the office of the PCDA (Pensions) Allahabad.

14. This issues with the concurrence of Finance Division of this Ministry vide their \mid D No 10(11)/2012/FIN/PEN dated 10.1.2013.
