- 2. The instalment of Dearness Allowance payable under these orders shall be paid in cash to all Haryana Government employees with the salary for the month of April, 2017 to be paid in May, 2017.
- 3. The payment of arrears of enhanced Dearness Allowance for the month from January, 2017 to March 2017 shall be made in the month of May, 2017.
- 4. The provision contained in para 3,4,5, & 7 in FD's instruction dated 25th November, 2016 shall continue to be applicable while regulating Dearness Allowance under these instructions.
