
Sub: Revised rates of stipend to Special Class Railway Apprentices.

Consequent upon the promulgation of Railway Services (Revised Pay) Rules, 2008, on the basis of the recommendations of the Sixth Central Pay Commission, the issue of revision of the rates of stipend to Special Class Railway Apprentices has been under consideration. The President is pleased to decide the following revised rates of stipend for SCRAs:-

First	4000	9100
Second	4000	9100
Third	4200	9400
Fourth (First six months)	4200	9400
(Last six months)	4400	9700

3. The apprentices will draw the revised rates of Dearness Allowance appropriate to the revised rates of stipend.


