Preamble:

In Government Order dated: 01-06-2017 read at above Government have constituted 6th State Pay Commission consisting of a Chairman and two Members respectively. Accordingly, the Chairman and Members have assumed charge of the office on 01-06-2017.

Therefore, Government are now pleased to specify the terms and conditions of appointment of Chairman and Members. Accordingly, the following orders are issued.

The terms and conditions of appointment of the Chairman and Members of the 6th State Pay Commission are as specified below:


i) Remuneration of Rs.2.5 lakhs (two lakhs and fifty thousand) per month to the Chairman of the 6th State Pay Commission.

Remuneration of Rs.2.25 lakhs (two lakhs and twenty five thousand) per month to each Member of the 6th State Pay Commission.

ii) They are entitled to home telephone and mobile charges at the rate of Rs.5000/- per month.

iii) In case of travel outside the headquarters, they are entitled to claim TA and DA at the highest rate admissible for the State Government Officers.
