Subject: Revision of Casualty Pensionary Awards in respect of Pre-2006 Armed Forced Officer and JCOs/ ORs Pensioners: Clarification.

Reference: This office Circular No. 560 dated 08.06.2016 and Circular No. 565 dated 22.08.2016, Circular No. 547 and 548 dated 11.09.2015

Provisions for "the minimum guaranteed rates of disability Element/ Liberalised disability Element/ War injury Element were already made w.e.f. 24.09.2012 vide GOI, MOD letter No. 16(01)/2014-D(Pen/Pol) dated 10.04.2015 circulated vide this office Circular No. 542 dated 27.05.2015.

- 2. Consequent upon issue of GOI, MOD letter No. 16(01)/2014/D(Pen/PoI) dated 18.05.2016, the above provisions have been made applicable w.e.f. 01.01.2006 instead of 24.09.2012 which has already been circulated vide this office Circular No. 560 dated 08.06.2016.
- 3. As per Para- 4(h) of GOI, MOD letter No. 16(01)/2014/D(Pen/PoI) dated 18.05.2016, "Service element of War Injury Pension in invalidment case will be given for the maximum of terms of engagement for the rank of Armed Force Personnel from which he had invalided out." Accordingly, while revising the **SERVICE ELEMENT** of **WAR INJURY PENSION** in invalidment cases, the **Service Element** will be revised as per **maximum terms of engagement for the rank** from which the individual had been invalided out from service (as provided in GOI, MOD letter No. 1(04)/2015(II)-D(Pen/PoI) dated 03.09.2015 and No. 1(04)/2015(I)-D(Pen/PoI) dated 03.09.2015 circulated vide this office Circular No. 547, 548 dated 11.09.2015).
- 4. After introduction of 6<sup>th</sup> CPC orders, Service pension/ Service Element is calculated on the basis of last pay drawn and qualifying service has no specific role in determination of Service Pension/ Service Element i.e. same is calculated on the basis of 50% of the

emoluments last drawn. In other words, full Service pension/ Service Element is granted and no proportionate reduction is made for lesser qualifying service. Accordingly Revision of SERVICE **ELEMENT** and **WAR INJURY ELEMENT** under **OROP** (Circular No. 555 dated 04.02.2016) will be carried out on the basis of actual Qualifying Service rendered by the individual.

- All other terms and conditions shall remain unchanged. 5.
