Fixation of pay of re-employed pensioners who are covered by CCS(Pension) Rules, 1972- terms and conditions thereof.

The undersigned is directed to refer to this department's Office Memorandum No.Fin(C)B(7)10/84 dated 1st December, 1988, Fin-C-B(7)-10/98 dated 8th September, 1999, Fin(C)B(7)13/2009 dated 19th April, 2010 and 16th July, 2016 on the subject cited above and to say that the question relating to modifying the guidelines contained in Office Memorandum dated 16th July, 2016 was engaging the attention of the government for some time past.

In supersession of this Office Memorandum of even number dated 16th July, 2016, it has been decided that the terms and conditions of reemployment of persons covered by CCS(Pension) Rules, 1972 may be decided by the respective Administrative Departments on the following lines:-
