### **Government order No: FD 1 SRS 2019 Bangalore, Dated 11.01.2019**

Government are pleased to order to regulate the annual incremental dates of State Government servants as the case may be with reference to 1<sup>st</sup> January or 1<sup>st</sup> July every year, instead of being regulated on different dates in a year.

This order shall come into force with effect from 01.01.2019.
