

It has been decided to extend the facility of permitted Passes and Special Leave to the participating women workers of one Zonal Committee meeting of Railway Women Workers in lieu of one of the Working Committee meetings of the affiliate union of NFIR subject to the maximum of the number of working committee members. However, no demand for increase in total number of Working Committee meetings will be considered. Further, conferences should not be held during peak seasons viz. May-June and October-December, when passenger rush is more and so sparing of staff may not be administratively desirable.
