**Subject : Implementation of Government's decision on the recommendations of the
5th Central Pay Commission - grant of fixed medical allowance @ Rs.100
p.m. to the Railway pensioners/family pensioners.**

In reference to orders issued by the Department of Pensions and Pensioners' Welfare on the recommendations of the 5th Central Pay Commission regarding grant of Medical Allowance of Rs. 100/- per month to pensioners and family pensioners, the matter of granting similar benefit to Railway pensioners and family pensioners has been under consideration of the Ministry of Railways. Sanction of the President is hereby accorded to the grant of fixed medical allowance @ Rs.100/- p.m. to railway pensioners/family pensioners residing outside the City/town/municipality limits of places where a Railway hospital/health unit/Lock up dispensary is situated, subject to fulfilment of the conditions laid down in the following paragraphs.

2. A list of places where Railway hospitals/health units/Lock up Dispensaries exist, is enclosed as **Annexure III** for guidance. Pensioners / family pensioners residing anywhere within the jurisdiction of the city/town/municipality etc. where the medical facilities listed in Annexure III are located, **shall not be entitled** for grant of Medical Allowance.

3. The benefit of Medical Allowance shall be available only to Railway pensioners/family pensioners, and **shall not be admissible** to those who have retired under the Contributory Provident Fund scheme. Grant of the benefit will be further subject to the condition that the concerned pensioners/family pensioners are eligible for medical facilities after retirement under any of the existing Health care schemes in the Railways. Actual enrolment under such a scheme shall not, however, be a pre-requisite.

4. Existing pensioners as well as the future retirees shall have to exercise one time option in the prescribed form (**Annexure-I**) to avail of medical facilities at OPD of Railway Hospitals or to claim fixed medical allowance of Rs.100/- p.m. In the case of future retirees, the option in the prescribed form for availing the benefit of Medical Allowance shall be obtained by the concerned Head of Office along with other pension papers and necessary authorisation for payment of Medical Allowance included in both halves of the Pension Payment Order itself. In the case of existing pensioners, the pension disbursing authority shall obtain the option and the Undertaking in the form placed at **Annexure-I**. Based on these, the Pension Disbursing Authority shall authorise payment of Medical Allowance @ Rs. 100 per month. The fact whether the pensioner/family pensioner has opted for Medical Allowance or not shall be prominently endorsed by the Pension Disbursing Authority on both halves of the PPO. In other words, the Pension Disbursing Authority shall make an appropriate endorsement on the PPO irrespective of whether the pensioner/family pensioner opts for the benefit of Medical Allowance or not.

5. The payment of Medical Allowance shall be made to the pensioner by the pension disbursing authority along with pension/family pension on monthly basis.

6. Pensioner/family pensioners residing in areas lying within the jurisdiction of places listed in **Annexure-III** are not eligible for the benefit of Medical Allowance. Accordingly, when

विषय :-पांचवे केंद्रीय वेतन आयोग की सिफारिशों पर सरकार के निर्णय का कार्यान्वयन - रेलवे पेंशनभोगियों/परिवार पेंशनभोगियों को 100/- रु. प्रतिमाह की दर पर नियत चिकित्सा भत्ता प्रदान करना .

पेंशनभोगियों तथा परिवार पेंशनभोगियों को 100/- रु. प्रतिमाह का चिकित्सा भत्ता प्रदान करने के संबंध में पांचवे केंद्रीय वेतन आयोग की सिफारिशों पर पेंशन तथा पेंशनभोगी कल्याण विभाग द्वारा जारी किए गए आदेशों के संदर्भ में, रेलवे पेंशनभोगियों तथा परिवार पेंशनभोगियों को ऐसे लाभ देने से संबंधित मामला रेल मंत्रालय के विचाराधीन रहा है . उस शहर/नगर/नगरपालिका जहां रेलवे अस्पताल /स्वास्थ्य इकाई/लॉक अप डिस्पेंसरी स्थित है, की सीमा से बाहर रहने वाले रेलवे पेंशनभोगियों को 100/- रु. प्रतिमाह की दर पर नियत चिकित्सा भत्ता प्रदान करने के लिए एतद्द्वारा राष्ट्रपति की स्वीकृति प्रदान की जाती है जो निम्नलिखित पैराग्राफों में निर्धारित शर्तों को पूरा करने पर निर्भर करेगा .

2. उन स्थानों की सूची , जहां रेलवे अस्पताल /स्वास्थ्य इकाई/लॉक अप डिस्पेंसरी मौजूद है , अनुबंध-III के रूप में संलग्न है , उस शहर/नगर/नगरपालिका जहां के क्षेत्राधिकार में कहीं भी रहने वाले पेंशनभोगी / परिवार पेंशनभोगी चिकित्सा भत्ता प्राप्त करने के पात्र नहीं होंगे .

3. चिकित्सा भत्ते का लाभ केवल रेलवे पेंशनभोगियों /परिवार पेंशनभोगियों को ही दिया जाएगा तथा यह उन कर्मचारियों के लिए स्वीकार्य नहीं होगा जो अंशदायी भविष्य निधि योजना के तहत सेवानिवृत्त हुए हैं . यह लाभ इस शर्त के अध्येय प्रदान किया जाएगा कि संबंधित पेंशनभोगी / परिवार पेंशनभोगी रेलों पर मौजूद किसी भी हेल्थ स्कीम के अंतर्गत

a pensioner/family pensioner registered under one of the existing medical schemes for retired Railway employees and residing in areas lying outside the jurisdiction of places listed in Annexure-III, approaches a Railway Hospital/Health Unit for treatment as OPD patient, he/she shall produce the PPO, duly endorsed by the Pension Disbursing Authority for verification of the fact that he/she has not opted for the facility of Medical Allowance. Upon such verification, the concerned Medical Authority shall make an appropriate endorsement on the Medical Card, indicating the status in respect of option for Medical Allowance.

7. As and when grant of medical allowance to a pensioner/family pensioner is authorised by the pension disbursing authority, intimation to this effect shall be sent to the concerned FA&CAO/ Pay and Accounts Office in the prescribed proforma (Annexure-II).

8. The Railways may consider issuing distinctive colour medical identification cards to those amongst the future retirees who opt for the facility of Medical Allowance. Cards of such colour may also be issued to existing pensioners who choose to opt for the benefit of Medical Allowance.


9. The grant of Medical Allowance is intended to meet expenditure on day to day medical expenses that do not require hospitalisation. Those opting for the facility of Medical Allowance shall, therefore, not be entitled to receive treatment as Outdoor Patients. However, pensioners who are members of any of the existing Health Care schemes for retired Railway employees, will not be debarred from receiving treatment for chronic illnesses requiring specialised investigations or long term treatment for chronic diseases, even if such treatment is received on outpatient basis.

10. These orders will take effect from 1-12-1997. Grant of Medical Allowance for the period commencing from the actual date of retirement, but not before 1-12-1997, up to the date of issue of these orders can be authorised by the Pension Disbursing Authorities if the pensioner/family pensioner gives a declaration in proforma placed at Annexure-IV.

11. This issues with the concurrence of Finance Directorate of the Ministry of Railways.

सेवानिवृत्ति के बाद चिकित्सा सुविधा के लिए पात्र हैं . बहरहाल, ऐसी योजना के अंतर्गत वारस्तविक नामांकन पूर्व अपेक्षित नहीं होगा .

4. मौजूदा पेंशनभोगी तथा भविष्य में सेवानिवृत्त होने वाले कर्मचारियों को रेलवे अस्पतालों के बहिरंग रोगी विभाग में चिकित्सा सुविधाएं प्राप्त करने अथवा 100/- रु. प्रतिमाह का नियत चिकित्सा भत्ता लेने के लिए निर्धारित फार्म (अनुबंध I) में एक बारगी विकल्प देना होगा . भविष्य में सेवानिवृत्त होने वाले कर्मचारियों के मामले में चिकित्सा भत्ते का लाभ लेने के लिए निर्धारित फार्म में विकल्प संबंधित कार्यालय के प्रधान द्वारा पेंशन के अन्य कागजों के साथ लिया जाएगा तथा पेंशन भुगतान आदेश के अर्द्धभागों में चिकित्सा भत्ते के भुगतान के लिए आवश्यक प्राधिकार किया जाएगा . मौजूदा पेंशनभोगियों के मामले में , पेंशन संवितरण प्राधिकारी अनुबंध I में दिये गये फार्म में विकल्प व वचनबद्धता प्राप्त करेंगे . इनके आधार पर पेंशन संवितरण प्राधिकारी 100/- रु. प्रतिमाह की दर पर चिकित्सा भत्ते का भुगतान प्राधिकृत करेगा . यह तथ्य कि पेंशनभोगी / परिवार पेंशनभोगी ने चिकित्सा भत्ते के लिए विकल्प दिया है अथवा नहीं, पेंशन संवितरण प्राधिकारी द्वारा पेंशन भुगतान आदेश के दोनों अर्द्धभागों पर प्रमुख रूप से पृष्ठांकित किया जाए . अन्य शब्दों में , पेंशनभोगी / परिवार पेंशनभोगी ने चिकित्सा भत्ते के लाभ के लिए विकल्प दिया है अथवा नहीं , का विचार किए बिना पेंशन संवितरण प्राधिकारी पेंशन भुगतान आदेश पर उपयुक्त पृष्ठांकन करेगा .

5. पेंशन संवितरण प्राधिकारी द्वारा मासिक आधार पर पेंशन/परिवार पेंशन के साथ पेंशनभोगी को चिकित्सा भत्ते का भुगतान किया जाएगा .

6. अनुबंध III में सूचीबद्ध स्थानों के क्षेत्राधिकार में आने वाले क्षेत्रों में रहने वाले पेंशनभोगी / परिवार पेंशनभोगी चिकित्सा भत्ते के लाभ के पात्र नहीं है . तदनुसार , जब सेवानिवृत्त रेल कर्मचारियों के लिए मौजूदा चिकित्सा योजनाओं में से किसी एक के अंतर्गत पंजीकृत तथा अनुबंध III में सूचीबद्ध स्थानों के क्षेत्राधिकार से बाहर वाले क्षेत्रों में रहने वाला पेंशनभोगी / परिवार पेंशनभोगी, बहिरंग रोग रूप में इलाज के लिए रेलवे अस्पताल /स्वास्थ्य इकाई में जाता है तो वह पेंशन संवितरण प्राधिकारी द्वारा विधिवत पृष्ठांकित पेंशन भुगतान आदेश प्रस्तुत करेगा / करेगी जिसमें इस तथ्य का सत्यापन किया गया हो कि उसने चिकित्सा भत्ते की सुविधा के लिए विकल्प नहीं दिया है . ऐसे सत्यापन के आधार पर संबंधित चिकित्सा प्राधिकारी चिकित्सा कार्ड पर उपयुक्त पृष्ठांकन करेगा जिसमें चिकित्सा भत्ते के लिए विकल्प के संबंध में स्थिति बताई जाएगी .

7. जब कभी पेंशन संवितरण प्राधिकारी द्वारा पेंशनभोगी / परिवार पेंशनभोगी को चिकित्सा भत्ते का अनुदान प्राधिकृत किया जाता है , इस

आशय की सूचना निर्धारित प्रोफार्मा (अनुबंध II) में वि.स. एवं मु.ले.धि. / संबंधित वेतन एवं लेखा कार्यालय को भेजी जाए .

8. रेलों भविष्य में सेवानिवृत्त होने वाले उन कर्मचारियों जिन्होंने चिकित्सा भत्ते की सुविधा के लिए विकल्प दिया है , अलग-अलग रंग के चिकित्सा पहचान कार्ड जारी करने के बारे में विचार करें . ऐसे रंग के कार्ड उन मौजूदा पेंशनभोगियों को भी जारी किए जाएं जिन्होंने चिकित्सा भत्ते के लाभ के लिए विकल्प दिया है .

9. चिकित्सा भत्ता दिन-प्रतिदिन के उस चिकित्सा व्यय को पूरा करने के लिए दिया जाता है जिसमें अस्पताल में भर्ती होने की आवश्यकता न पड़े . अतः जिन कर्मचारियों ने चिकित्सा भत्ते की सुविधा के लिए विकल्प दिया है , बहिरंग रोगी के रूप में इलाज कराने के लिए पात्र नहीं होंगे . बहरहाल जो पेंशनभोगी सेवानिवृत्त रेल कर्मचारियों के लिए मौजूदा स्वास्थ्य देखभाल योजनाओं में से किसी एक का भी सदस्य है , को पुरानी बीमारी जिसके लिए विशेष जांच अपेक्षित हो , के लिए इलाज कराने अथवा पुरानी बीमारी के लिए लंबी अवधि के इलाज से वंचित नहीं रखा जाएगा, चाहे यह इलाज बहिरंग रोगी के रूप में कराया गया हो .

10. ये आदेश 1.12.97 से प्रभावी होंगे . सेवानिवृत्ति की वास्तविक तारीख परंतु 1.12.97 से पहले नहीं, सेइन आदेशों के जारी होने की तारीख तक की अवधि के लिए चिकित्सा भत्ते की मंजूरी पेंशन संचितरण प्राधिकारियों द्वारा प्राधिकृत की जा सकती है, लेकिन इसके लिए पेंशनभोगी /परिवार पेंशनभोगी को अनुबंध IV में दिए गये प्रोफार्मा में घोषणा देनी होगी .

11. इसे रेल मंत्रालय के वित्त निदेशालय की सहमति से जारी किया जा रहा है.


