2. With respect to above, it is stated that the issue stands referred to Ministry of Health & Family Welfare (MHFW) vide OM dated 04.12.2018. In response, MHFW advised vide letter dated 27.06.2019 that the issue has already been taken up with Department of Expenditure (DoE) for clarification and requisite clarifications are awaited from DoE.

3. Since, the issue is now pending with DoE, an OM dated 02.12.2012 has been sent to DoE requesting to expedite clarification on the issue duly forwarding NFIR's letters mentioned above. Copy of the same is enclosed as *Annexure-I*.

Sub:- Revised rates of one/two additional increments (non-absorbable) to the Nursing Staff under 7th CPC pay structure.

Please refer to this Ministry's OM mentioned above seeking clarification regarding revised rates of one/two additional increments (non-absorbable) to the eligible Nursing Staff under 7th CPC pay structure. In this regard Ministry of Health & Family Welfare vide their Letter F. No. Z.28015/53/2017-N(Pt.) dated 27.06.2019 (copy enclosed as *Annexure-I*) advised that the issue has already been taken up with Department of Expenditure for clarification and requisite clarification are awaited from Department of Expenditure. In due course, a D.O. letter No. PCVI/2008/NAC/1 dated 23.09.2019 (copy enclosed as *Annexure-II*) from Addl. Member (Staff)/Railway Board to Addl. Secretary(Pers.)/Department of Expenditure has also been sent requesting for early resolution of the issues pending with Ministry of Finance including the issue of revised rates of additional increments to Nursing Staff.

2. With respect to above, it is stated that considerable time has passed in want of clarification on the issue. Staff Federations are raising the issue and Zonal Railways are also seeking clarification in this regard. Representations dated 26.08.2019 and 21.10.2019 received from National Federation of Indian Railwaymen (NFIR) are enclosed for reference. Therefore, it is requested that clarification on the issue may be expedited please.
